





Winter Field Day beginning at 19:00 18:59 on Sunday.

WFD is always on the last full weekend of January, beginning at 19:00 UTC on Saturday and running though 18:59 on Sunday.

You can operate on the 160, 80, 40, 20, 15, and 10 meter HF bands and all bands above 50 MHz.

To be considered for scoring, all participants must submit their log entries before 11:59 UTC on March 1st . All logs must be submitted in the Cabrillo formation and contain the proper exchange data. Late entries cannot be accepted.

WFD participation and results are tallied and posted on the website for future reference. Our goal is to logs scored by May 30th and posted the first week of June. <u>https://winterfieldday.org/resources.php</u>



(625 ILCS 5/12-610.2) - Sec. 12-610.2. Electronic communication devices.

(a) As used in this Section:

"Electronic communication device" means an electronic device, including, but not limited to, a hand-held wireless telephone, hand-held personal digital assistant, tablet, or a portable or mobile computer, but does not include a global positioning system or navigation system or a device that is physically or electronically integrated into the motor vehicle.

(b) A person may not operate a motor vehicle on a roadway while using an electronic communication device, including using an electronic communication device to watch or stream video, participate in any video conferencing application, including, but not limited to, Zoom, Microsoft Teams, or WebEx, or access any social media site, including, but not limited to, Facebook, Snapchat, Instagram, or Twitter. The exemptions in paragraphs (3) and (9) of subsection (d) do not apply when a person is using the electronic communication device to watch or stream video, participate in any video conferencing application, or access any social media site.

(b-5) A person commits aggravated use of an electronic communication device when he or she violates subsection (b) and in committing the violation he or she is involved in a motor vehicle crash that results in great bodily harm, permanent disability, disfigurement, or death to another and the violation is a proximate cause of the injury or death.

(c) A violation of this Section is an offense against traffic regulations governing the movement of vehicles. A person who violates this Section shall be fined a maximum of \$75 for a first offense, \$100 for a second offense, \$125 for a third offense, and \$150 for a fourth or subsequent offense, except that a person who violates subsection (b-5) shall be assessed a minimum fine of \$1,000.

(d) This Section does not apply to:

(1) a law enforcement officer or operator of an emergency vehicle while performing his or her official duties;

(1.5) a first responder, including a volunteer first responder, while operating his or her own personal motor vehicle using an electronic communication device for the sole purpose of receiving information about an emergency situation while en route to performing his or her official duties;

(2) a driver using an electronic communication device for the sole purpose of reporting an emergency situation and continued communication with emergency personnel during the emergency situation;

(3) a driver using an electronic communication device in hands-free or voice-operated mode, which may include the use of a headset;

(4) a driver of a commercial motor vehicle reading a message displayed on a permanently installed communication device designed for a commercial motor vehicle with a screen that does not exceed 10 inches tall by 10 inches wide in size;

(5) a driver using an electronic communication device while parked on the shoulder of a roadway;

(6) a driver using an electronic communication device when the vehicle is stopped due to normal traffic being obstructed and the driver has the motor vehicle transmission in neutral or park;

(7) a driver using two-way or citizens band radio services;

(8) a driver using two-way mobile radio transmitters or receivers for licensees of the Federal Communications Commission in the amateur radio service;

(9) a driver using an electronic communication device by pressing a single button to initiate or terminate a voice communication; or

(10) a driver using an electronic communication device capable of performing multiple functions, other than a hand-held wireless telephone or hand-held personal digital assistant (for example, a fleet management system, dispatching device, citizens band radio, or music player) for a purpose that is not otherwise prohibited by this Section.

(e) A person convicted of violating subsection (b-5) commits a Class A misdemeanor if the violation resulted in great bodily harm, permanent disability, or disfigurement to another. A person convicted of violating subsection (b-5) commits a Class 4 felony if the violation resulted in the death of another person.

FRRL Groups.io Group Message Board

The FRRL has an active mailing list group on Groups.io. Members in good standing are eligible to join the mailing group. You should receive an invite upon joining the group to the email listed in your application. Your active club membership is required to be a member of our Groups.io group.

The group provides the following features:

Messages/Mailing List

View the calendar

Access to files including the club Bylaws and Membership Roster Access to photos submitted by members. Great for sharing projects you're working on! How do I join?

When your FRRL club membership is confirmed you will receive an email invite from Groups.io. The club membership form requests an email to be used by the club or members to contact you for club or ham radio related subject. If you already have a Groups.io account under a different email and wish to combine them there is a second field for that email. If it is filled in, you will get the invite in that email.

When you join, you can choose a profile you'd like to display to the group, select the email address at which you'd like to receive group messages, choose how you receive group messages, and more. You can receive messages via email or by reading the message boards within the group.

GOUPS.10 - It's more than just messages.

When you first login to your groups.io account, at https://groups.io, you will be presented with a list of the groups that you belong to.

Click on FRRL|Members

Just a friendly reminder that the FRRL conducts regular nets on 10 meters on Monday nights local time.

7:30pm (00:30 UTC) - 28420 kHz. A net for new Hams (especially Technicians) to encourage anyone with a license to get on the air using a shortwave frequency. Many new Amateur Radio Operators find it easy to build a 10 meter antenna when they buy their first HF transceiver. Anyone with a valid FCC Amateur Radio license can join in the conversation where we can talk about anything from pets, cars, activities, antennas, radios, etc. Here is an example of a 28420 net QSO (see MP3 audio Attachment).

8:00pm (01:00 UTC) - 28150 kHz, CW 10-10 net.

8:30pm (01:30 UTC) - 28720 kHz Phone (SSB) 10-10 net. 10-10 nets are sponsored by members of the Ten-Ten International Net organization. 





The Fox River Radio League (FRRL) presents regular training classes focused toward new Amateurs interested in gaining their Technician class license or upgrading to the General and Extra class licenses.

These are free courses where you will learn everything you need to receive or upgrade to the appropriate FCC radio license.

The textbook for the class will be the official ARRL License Manual. Books are available for purchase through the ARRL website.

Classes are instructor-led, and you can expect engaging conversations to ensue around the topics of discussion.

In addition to our regularly scheduled bi-monthly testing we will be scheduling a dedicated VE session after discussing best availability with the class participants. For more information on VE sessions, please see VE Test Sessions.



The Radio Amateur's Code

The Radio Amateur is...

CONSIDERATE... He never knowingly operates in such a way as to lessen the pleasure of others.

LOYAL...He offers loyalty, encouragement and support to other amateurs, local clubs, the IARU Radio Society in his country through which Amateur Radio in his country is represented nationally and internationally.

PROGRESSIVE... He keeps his station up to date. It is well build and efficient. His operating practice is above reproach.

FRIENDLY... He operates slowly and patiently when requested; offers friendly advice and counsel to the beginner; kind assistance, cooperation and consideration for the interests of others. These are the marks of the amateur spirit.

Every licensed amateur, regardless of membership in ARRL or any other local or national organization is eligible to apply for membership in ARES. Training may be required or desired to participate fully in ARES. Please inquire at the local level for specific information. Because ARES is an amateur radio program, only licensed radio amateurs are eligible for membership. The possession of emergency-powered equipment is desirable, but is not a requirement for membership.






